In 1887, a Denver priest, two ministers and a rabbi recognized the need for cooperative action to address their city's welfare problems. The Rev. Myron W. Reed, Msgr. William J. O'Ryan, Dean H. Martyn Hart and Rabbi William S. Friedman put their heads together to plan the first united campaign for ten health and welfare agencies. They created an organization to serve as an agent to collect funds for local charities, as well as to coordinate relief services, counsel and refer clients to cooperating agencies, and make emergency assistance grants in cases which could not be referred. That year, Denver raised \$21,700 and created a movement that would spread throughout the country to become the United Way.

136 years later, United Way is still focused on mobilizing the caring power of communities and making a difference in people's lives in more than 1,800 regions nationally and internationally, providing billions in aid to people in need.

Our local United Way began as the Yuba-Sutter United Way in 1968 and steadily grew as it added "partner agencies" representing nearly all areas of service to people in need. Funding was raised through giving campaigns, along with designated giving from employees of local business and governmental bodies on a year-around basis.

Funds raised are shared, minus a modest overhead cost and internal program costs, are divvied up between internal and program costs and our partner agencies, with the amounts given to partners through discussions of a community-based committee.

Over the years, our local United Way has continued to provide funds to partner agencies based on designations by donors, supplemented by a pool of funds determined each year by the board of directors.

While Colusa County has been part of the footprint of our local United Way for many years, it was officially added to the name in 2017 to form the Yuba-Sutter-Colusa United Way.

Today, a board of directors of 19 highly-regarded members and our two-person staff, work to better our community.







What we do

Due to the ever-increasing need for assistance, we have a growing list of programs to assist our residents.

 Our local United Way office annually fields more than 500 telephone, website and social media requests for help with rental payments, utility payments, food distribution locations and many other critical needs. Over the last three years we have provided over \$41,000 annually to Yuba-Sutter Food Bank and local food pantries from our Summertime "Cash for Food Drive" and November Turkey Drive. For 25 years, YSC United Way has been the lead agency for Yuba and Sutter Counties for the Federal Emergency Food and Shelter Program, which over the past five years alone has brought \$1,700,000 to our region for the Food Bank, local food pantries, Casa de Esperanza, Salvation Army, the Regional Emergency Shelter Team (REST) and the Life Building Center.
